Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 8 May 2024 and launched on 19 December 2024, Sabaf S.p.A. informs that in the period between 10 March 2025 and 14 March 2025 acquired no. 1,553 treasury shares at an average unit price of \leq 14.3833 per share, for a total amount of \leq 22,344.25.
