Update on the execution of the buy-back programme

With reference to the buy-back programme approved by the shareholders on 8 May 2024 and launched on 19 December 2024, Sabaf S.p.A. informs that in the period between 20 January 2025 and 24 January 2025 acquired no. 9,269 treasury shares at an average unit price of € 14.6159 per share, for a total amount of € 135,298.81.
